



Subject: **PROMOTION TO THE GRADE OF 'SENIOR PRINCIPAL PRIVATE SECRETARY' (SR.PPS) ON REGULAR BASIS FOR THE DPC YEAR 2017-18 IN THE AFHQ STENOGRAPHERS SERVICE**

Reference this office note of even number dated 29<sup>th</sup> Jun 2017.

2. Consequent to inclusion in the Select List for promotion to the grade of Sr.PPS for the panel year 2017-18, **Shri Ghan Shyam** (DOB: 01.07.1965, ID No. A157144), Principal Private Secretary (PPS) in Level -11 in Pay Matrix (pre-revised scale in PB-3 with a Grade Pay of Rs.6,600/-), of DRDO is promoted to the grade of 'Sr.PPS' in Level-12 in Pay Matrix (pre-revised scale in PB-3 with a Grade Pay of Rs.7,600/-) Group 'A' (Gazetted) on regular basis against vacancy arising due to promotion of Shri Parshotam Lal as Exe. PPS. On promotion, Shri Ghan Shyam is hereby posted to Air HQ vice Smt Neerja Bhushan, Sr.PPS (transferred).
3. However, Promotion of Shri Ghan Shyam will be effective after assumption of charge of Shri Parshotam Lal in higher grade i.e Exe. PPS or assumption of charge of Sr.PPS, whichever is later.
4. The Pay of the official may be fixed in the grade of Sr. PPS in terms of provisions laid down under FR-22, as amended from time to time and the instruction stipulated in CCS (RP) Rules, 2016.
5. The promotion would be subject to final outcome of Writ Petition No. 3091/2007 filed in the Hon'ble High Court of Delhi.
