| 7.         | <p>Para 9 of Part-B/Part-II of RFP may be deleted and replaced as under :</p> <p><b>9. Anti-Virus</b><br/> <b>(a) To ensure security of data and system, the server may be provided with necessary anti-virus by the bidder.</b></p>   |
| 8.         | <p>In Para 23 of Part-B/Part-II, the words <b>“free maintenance and” may be deleted.</b></p> <p>Under Para 20 of Part-IV of the RFP, the clause (a) may be substituted as under :</p> <p><b>(a) On expiry of warranty, the vendor will enter into AMC for further five (5) years.</b></p> <p>In the price bid format given in Part-V of the RFP under Sr. No. 4 &amp; 5, the following words may be added in parenthesis at the end <b>(after expiry of warranty).</b></p>               |
